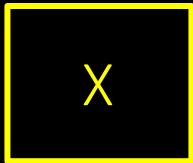


Pacman is the number 1 arcade franchise in the world, selling over 70 million units and grossing 15 Billion dollars.

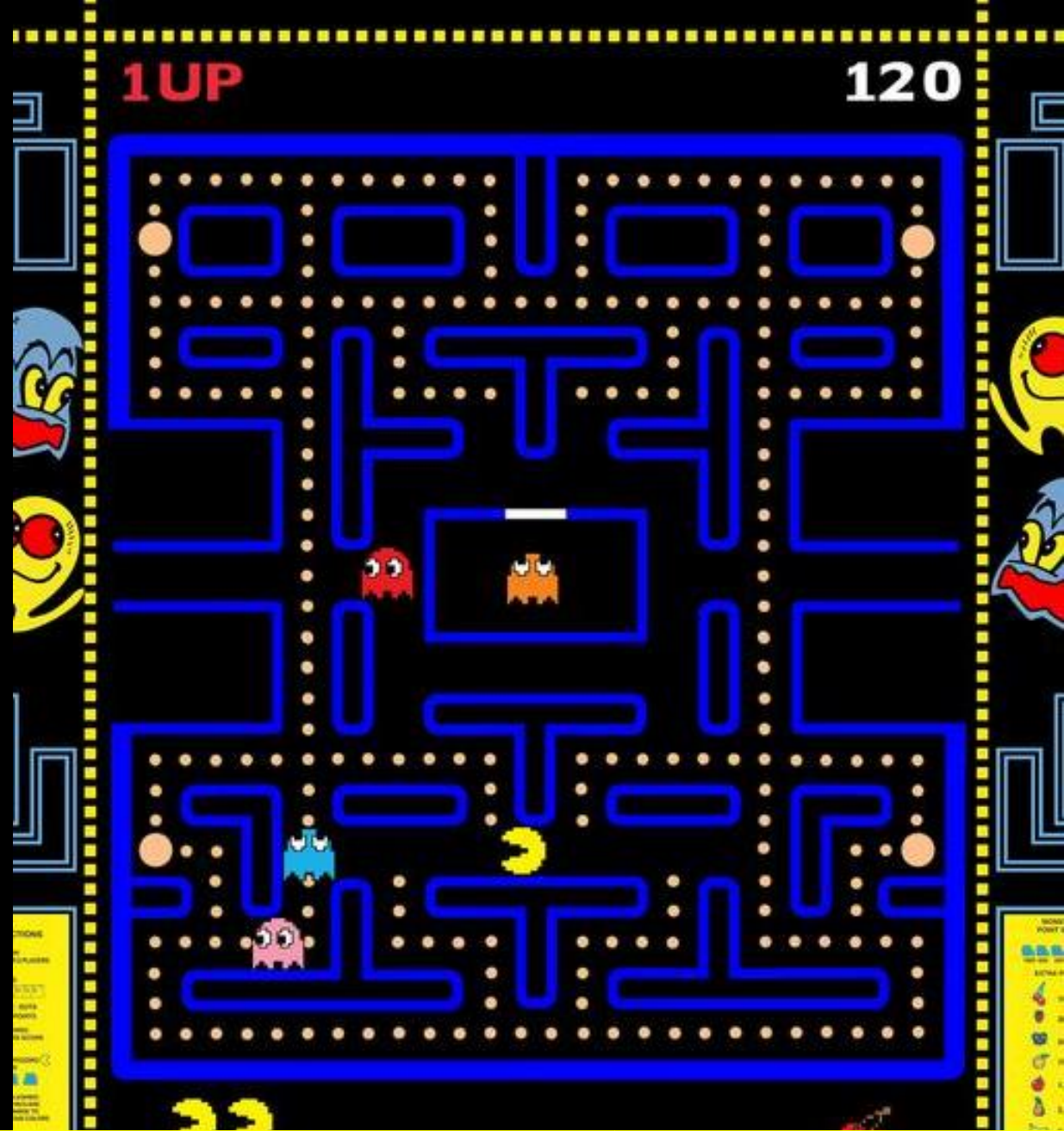


According to Arcades Australia, "Statistics estimate popular games may generate anywhere from \$350-\$1000 weekly revenue streams."

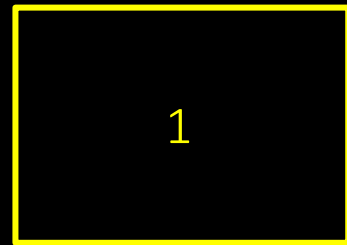


Arcade machines are the highest grossing profit margin assets in the vending world. It doesn't need restocking, and it can be managed remotely.

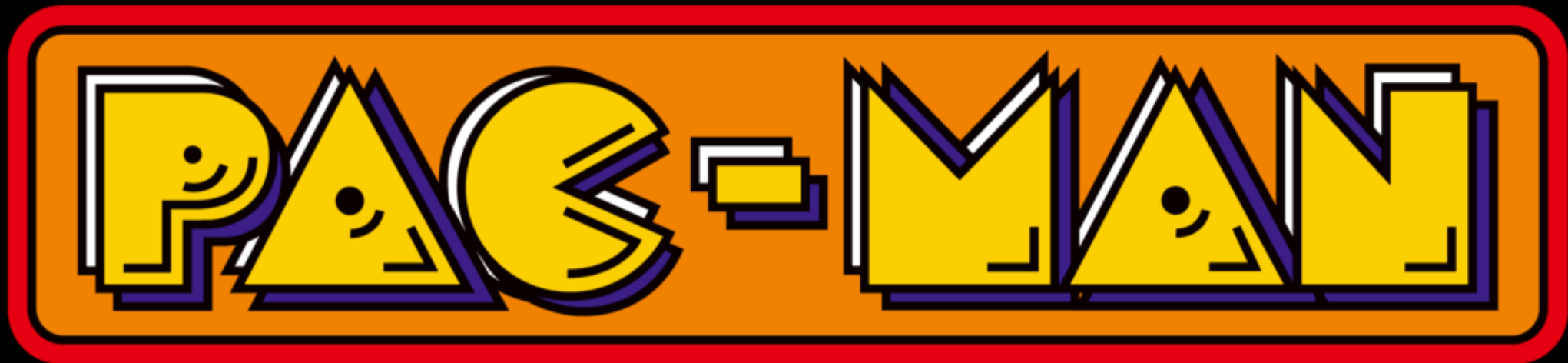

# THE PROCESS

Total length of time: 5 – 10 weeks.

STEP 1.

After the Investment, in either premium or no premium, we begin the venue selection process. In which we notify the SBE venue network of a new account, and we begin the bidding process to select the best current venue in the network. (4-8 weeks.)

STEP 2.

Once a venue has been selected, we then install the asset at the venue. This process takes several technicians and the machine itself must ship from Chicago to its new home. (1-2 weeks.)

STEP 3.

Once installed, the machine is operational. We the company can then manage the machines remotely through a software called Nayax. As an ongoing process, your investment in the machine will be managed daily to accumulate the highest net profit margins possible.







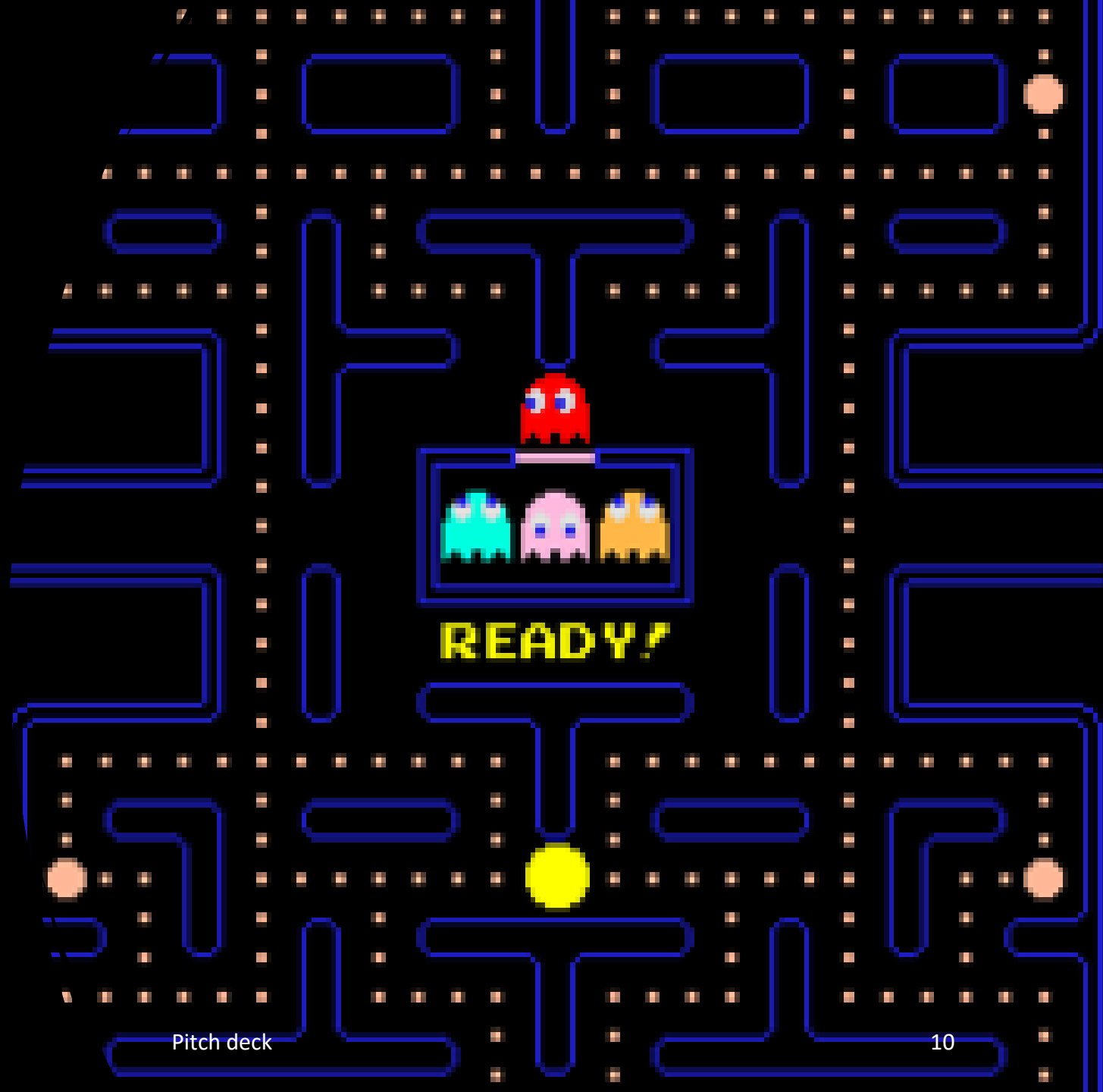
# HOW YOU CAN GET INVOLVED!
